Health and safety

3.2 Health and safety general standards

Policy statement for St Joseph's Pre-school

St Joseph's Pre-school believes that the health and safety (H&S) of children is of paramount importance. We make our setting a safe and healthy place for children, parents, staff and volunteers¹.

- We aim to make children, parents and staff aware of H&S issues and to minimise the hazards and risks to enable the children to thrive in a healthy and safe environment.
- Our member of staff responsible for H&S is: **Natalie Finn-Powers**, Lead Practitioner. She is competent to carry out these responsibilities.
- She has undertaken H&S training and regularly updates her knowledge and understanding.
- We display the necessary H&S poster on **the noticeboard in the kitchen area**.
- **Kayleigh Niven** has undertaken fire safety training.

Insurance cover

We have public liability insurance and employers' liability insurance. The certificate for public liability insurance is displayed on a noticeboard in the foyer of the Leigh Building.

Procedures

Health and Safety Awareness

- Our induction training for staff and volunteers includes a clear explanation of H&S issues so that all adults are able to adhere to our policy and procedures as they understand their shared responsibility for health and safety. The induction training covers employee well-being, including manual handling and the storage of potentially dangerous substances.
- Records are kept of these induction training sessions and new staff and volunteers are asked to sign the records to confirm that they have taken part.
- H&S requirements are explained to the parents of new children so that they understand their importance in the daily activities at the setting.
- As necessary, H&S training is included in the annual training plans of staff, and health and safety is discussed regularly at staff meetings.
- We operate a no smoking policy², which also covers the use of e-cigarettes and vaping.
- Children are made aware of H&S issues through discussions, planned activities and routines.
- The setting is regularly risk assessed with regards to fire safety³ and hazards.

Safety of adults

- St Joseph's Pre-school complies with the manual handling operation regulations (MHOR) 1992, amended 2002.

- Adults are provided with guidance about the safe storage, movement, lifting and erection of equipment.
- Any work requiring the use of equipment will be carried out by a competent member of staff who has undergone appropriate training.
- All warning signs are clear and in appropriate languages.
- Adults do not remain in the building on their own or leave on their own after dark.
- The sickness of staff and their involvement in accidents is recorded. The records are reviewed termly to identify any issues that need to be addressed.
- In extreme weather conditions⁴, eg excessive heat in the summer, a member of the Committee will check with staff (setting based and home based), that they have what they need to stay safe. Where there is something to be done and it is under the Committee's control, this will be dealt with as soon as possible. The setting has a separate policy re hot weather for the children⁵.

First Aid

The Health and Safety (First Aid) Regulations 1981 require employers to provide adequate and appropriate equipment, facilities and personnel to ensure their employees receive immediate attention if they are injured or taken ill at work.

While the regulations do not require employers to provide first aid for anyone other than their own employees, the DfE Guidance "First Aid in Schools, Early Years and Further Education" strongly recommends that all educational establishments consider the needs of non-employees such as pre-schoolers, students and visitors when making provision for first aid.

Control of Substances Hazardous to Health (COSHH)

- We keep a record of all substances that may be hazardous to health - such as cleaning or gardening chemicals. This states what the risks are and what to do if they have contact with eyes, skin or are ingested. It also states where they are stored and in what quantities.
- We keep all cleaning chemicals in their original containers.
- The Leigh Building is steamed cleaned once a term (ie. Autumn, Spring and Summer). A deep clean is carried out as and when required. When the building is shared, e.g. with St Joseph's Nympsfield Out of School Club (OOSC), the cost will be shared (60:40) as applicable.

Building maintenance

- St Joseph's Pre-school carries out a risk assessment of the Leigh Building at the start of each half-term. Any concerns are logged and flagged up to the School Business Manager of St Joseph's Catholic Primary School.
- If during a half-term an issue with the building arises, eg. lack of heating, replacement light bulb, the Lead Practitioner will inform the School Business Manager who will organise any required works.

Windows

- Low level windows are made from materials that prevent accidental breakage or are made safe.
- Windows are protected from accidental breakage or vandalism from people outside the building.

⁴ Whilst there is no law on either a maximum or minimum temperature, government guidance suggests a minimum of 16°C for sedentary work or 13°C for physical work; there is nothing for a maximum temperature.

- Windows above the ground floor are secured so that children cannot climb through them.

Doors

- We take precautions to prevent children's fingers from being trapped in doors.

Floors

- All floor surfaces are checked daily to ensure they are clean and even, not wet or damaged.

Electric/gas equipment

- All electric/gas equipment conforms to safety requirements and is checked regularly. Portable appliances are PAT tested (portable appliance testing) every 2 years by a qualified electrician. This testing is done in conjunction with OOSC and the cost is shared.
- Our boiler/electrical switch gear/meter cupboard is not accessible to the children.
- Fires, heaters, electric sockets, wires and leads are properly guarded and the children are taught not to touch them.
- Storage heaters are checked daily to make sure they are not covered.
- There are sufficient sockets to prevent overloading.
- The temperature of hot water is controlled to prevent scalds.
- Lighting and ventilation is adequate in all areas including storage areas.

Storage

- All resources and materials from which children select are stored safely.
- All equipment and resources are stored or stacked safely to prevent them accidentally falling or collapsing.

Outdoor area

- Our outdoor area is securely fenced.
- Our outdoor area is checked for safety and cleared of rubbish before it is used.
- Adults and children are alerted to the dangers of poisonous plants, herbicides and pesticides.
- Where water can form a pool on equipment, it is emptied before children start playing outside.
- Our outdoor sand pit is covered when not in use and is cleaned regularly.
- All outdoor activities are supervised at all times.

Hygiene

- We regularly seek information from the Environmental Health Department and the Health Authority to ensure that we keep up-to-date with the latest recommendations.
- Our daily routines encourage the children to learn about personal hygiene.
- We have a daily cleaning routine for the setting which includes play room(s), kitchen, rest area, toilets and nappy changing areas.
- We have a schedule for cleaning resources and equipment by staff, Parents volunteer to wash dressing-up clothes and furnishings.
- The toilet area has a high standard of hygiene including hand washing and drying facilities.
- We implement good hygiene practices by:
 - Cleaning tables between activities;
 - Cleaning toilets regularly;
 - Wearing protective clothing - such as aprons and disposable gloves - as appropriate;
 - Providing sets of clean clothes;

- Providing tissues and wipes;
- Use of paper towels; and
- Ensuring individual use of flannels and towels.

Human waste disposal

- All human waste is disposed of appropriately. Body fluids and anything which comes into contact with body fluids are double wrapped in plastic bags and put in the appropriate bin. The bin is sealed so that it is inaccessible to children. Our contractor empties this bin 4-weekly.
- When disposing of such waste we put on disposable gloves and aprons which are also double wrapped in plastic bags and disposed of in the appropriate bin.
- Any surface that the waste has been in contact with is thoroughly cleaned using anti-bacterial cleaning fluid and cloths are disposed of in the above manner.
- If body fluid is on clothes the child is taken to a private area, the soiled clothes are removed and the child is washed with wipes or mild soap and warm water. The child is dressed in clean clothes. We ensure that the floor or surfaces where the child was changed is thoroughly cleaned by wiping up fluids, disinfecting and drying the area. The soiled clothes are rinsed in hot running water before being double wrapped for the parent to take home and wash.
- Regarding concerns over HIV and AIDS virus and hepatitis, extra vigilance is taken and all cuts and open wounds are covered with plasters. Good hygiene practice always takes place regardless of such concerns with gloves and aprons put on for protection and all waste disposed of appropriately.

Activities and resources

- Before purchase or loan, equipment and resources are checked to ensure that they are safe for the ages and stages of the children currently attending the setting.
- The layout of play equipment allows adults and children to move safely and freely between activities.
- All equipment is regularly checked for cleanliness and safety and any broken, damaged or unsafe items are removed from use immediately and repaired, replaced, or disposed of appropriately.
- All materials, including paint and glue, are non-toxic.
- Sand is clean and suitable for children's play.
- Physical play is constantly supervised.
- Children are taught to handle and store tools safely.
- Children who are sleeping are checked regularly⁶.
- Children learn about health, safety and personal hygiene through the activities we provide and the routines we follow.
- Any faulty equipment is removed from use and is repaired. If it cannot be repaired it is discarded.
- Large pieces of equipment are discarded only with the consent of the manager and the chairperson or owner.

All toys, equipment, and play resources used within St Joseph's Pre-school are compliant with relevant UK safety legislation, including the Toys (Safety) Regulations 2011 and BS EN 71 safety standards. Toys will carry the appropriate UKCA or CE marking where required.

Display screen equipment

- Staff are increasingly using tablets to record children's progress. Usage is regularly reviewed to assess whether staff need any further equipment (i.e. keyboard/mouse/desk).
- Children use the tablets for very short periods of time and are always supervised.

Fixed Asset Register

St Joseph's Pre-school maintains an up-to-date fixed asset register for all significant toys, equipment, furniture, and resources. The register supports effective health and safety management by enabling the monitoring, inspection, maintenance, and replacement of items used within the setting.

All equipment and resources will be checked regularly to ensure they are safe, clean, and suitable for use. Any damaged, faulty, or unsafe items will be removed immediately and repaired, replaced, or disposed of appropriately in line with the setting's health and safety procedures.

The fixed asset register will be reviewed regularly to support risk assessments, maintenance planning, inventory control, and compliance with relevant health and safety and early years requirements.
