1.12.2 Preventing Radicalisation

Policy statement for St Joseph's Nympsfield Out of School Club

At St Joseph's Nympsfield Out of School Club (OOSC) we ensure that through our vision, values, rules, curriculum and teaching we promote tolerance and respect for all cultures, faiths and lifestyles. The Trustee's also ensure that this ethos is reflected and implemented effectively in policy and practice and that there are effective risk assessments in place to safeguard and promote children's welfare.

We have a duty to prepare our children for life in modern Britain and to keep them safe. Children who attend the OOSC have the right to learn in safety. We do not tolerate bullying of any kind and will challenge derogatory language and behaviour towards others.

Preventing Radicalisation Policy

This is part of our commitment to keeping children safe. Since the 'Education and Inspections Act 2006' schools have a duty to promote community cohesion. Over the last few years, global events have led to a growth of extremist viewpoints, including advocacy of violent extremism.

Childcare providers have an important part to play in both educating children and young people about extremism and recognising when pupils start to become radicalised. In March 2015, statutory duties were placed on schools by the Counter Terrorism and Security Act (2015) which means they must work to prevent children being drawn into extremism.

Safeguarding children from all risks of harm is an important part of the OOSC's work and protecting them from extremism is one aspect of that.

Statutory Duties

The duty to prevent children and young people being radicalised is set out in the following documents.

- Counter Terrorism and Security Act (section 26)
- Keeping Children Safe in Education (latest version)
- Prevent Duty Guidance (latest version)
- Working Together to Safeguard Children (latest version)

It's a legal obligation for St Joseph's Nympsfield Out of School Club to comply with the Prevent

duty and help to protect young children from extremism. Prevent Duty has 4 themes:

- Risk assessment complete a risk assessment pinpointing any concerns relating to vulnerable children and radicalisation;
- Working in Partnership take appropriate action and refer people to Channel¹ when necessary;
- Staff Training undertake Prevent-awareness training; and
- IT Policies apply appropriate content filters on IT and internet equipment/software.

Definitions

<u>Extremism</u> is defined in the 2011 Prevent strategy as vocal or active opposition to fundamental British values, including democracy, the rule of law, individual liberty and mutual respect and tolerance of different faiths and beliefs. We also include in our definition of extremism calls for the death of members of our armed forces, whether in this country or overseas.

<u>*Radicalisation*</u> refers to the process by which a person comes to support terrorism and extremist ideologies associated with terrorist groups.

<u>British Values</u> are democracy, the rule of law, individual liberty and mutual respect and tolerance of those with different faiths and beliefs.

Role of the Play Leader

It is the role of the Play Leader to:

- ensure that the OOSC and its staff respond to preventing radicalisation on a day-to-day basis;
- ensure that the OOSC's curriculum addresses the issues involved in radicalisation; and
- ensure that staff conduct is consistent with preventing radicalisation.

Role of Designated Safeguarding Lead

It is the role of the designated safeguarding lead to:

- ensure that staff understand the issues of radicalisation, are able to recognise the signs of vulnerability or radicalisation and know how to refer their concerns;
- receive safeguarding concerns about children and young people who may be vulnerable to the risk of radicalisation or are showing signs of radicalisation;
- make referrals to appropriate agencies with regard to concerns about radicalisation;
- liaise with partners, including the local authority and the police;
- report to the Play Leader on these matters.

Role of staff

It is the role of staff to understand the issues of radicalisation, are able to recognise the signs of vulnerability or radicalisation and know how to refer their concerns. Staff will follow the "notice, check, share" procedure outlined in the Prevent Duty GOV.UK awareness training.

Internet Safety

The internet provides children and young people with access to a wide-range of content, some of which is harmful. Extremists use the internet, including social media, to share their messages. The filtering systems used in our OOSC blocks inappropriate content, including extremist content.

The Acceptable Use of ICT Policy² refers to preventing radicalisation and related extremist content. Staff know how to report internet content that is inappropriate or of concern. Staff are aware of the DfE's "<u>Educate against hate</u>" website.

Staff Training

Staff will be given training to help them understand the issues of radicalisation, are able to recognise the signs of vulnerability or radicalisation and know how to refer their concerns. This information also forms part of induction safeguarding training. Any important safeguarding briefings, eg. from NSCPCC³, are emailed to staff and discussed in the weekly staff meeting.

Designated Safeguarding Leads are likely to require additional, more regular training so that they can support others.

Safer Recruitment

We ensure that the staff we appoint to St Joseph's Nympsfield Out of School Club are suitable, our recruitment procedures are rigorous and we follow the statutory guidance published in part 3 of Keeping Children Safe in Education (latest version). At St Joseph's Nympsfield Out of School Club we ensure that we have a member on every recruitment panel who has received the appropriate recruitment and selection training and that we have more than one member of staff suitably trained.

All our staff are appropriately qualified and have the relevant employment history and checks to ensure they are safe to work with children in. References are sought from both the most recent employer and the most recent educational setting (if applicable). Internal references are only acceptable from someone with authority, not a work colleague. We endeavour to check that any electronic reference received is from legitimate source. Vetting and barring checks are undertaken on relevant people, including trustees and volunteers. We recommend that staff enrol on the DBS update service.

Signs of radicalisation

Although the signs of radicalisation differ from person to person, it may be a cause for concern if a child is seen to be:

- isolating away from friends and family;
- talking as if they are reading from a scripted speech;
- being unwilling or unable to discuss their views;
- becoming increasingly angry; or
- becoming more secretive.

Children who are at increased risk of radicalisation may suffer from low self-esteem, or be victims of discrimination or bullying.

Referral Process

Staff and visitors to St Joseph's Nympsfield Out of School Club must refer all concerns about children and young people who show signs of vulnerability or radicalisation must be passed to the Designated Safeguarding Lead using the usual methods for reporting other safeguarding concerns.

When there are significant concerns about a child, the Designated Safeguarding Lead in liaison with the Play Leader will make a referral to the appropriate body.

Depending on the severity of the matter, they may contact the local police or call the 101 nonemergency services number for advice and support.

Additionally, the Department of Education provides a telephone number (020 7340 7263) for education professionals that want to raise direct concerns relating to radicalisation.

Monitoring and Review

This policy will be monitored by the Trustees at least annually by receiving a report from the Designated Safeguarding Lead.
